Independent Examiner's Report

Independent Examiner's Report to the Trustees of the 6th West Lothian Scout Group
I report on the financial statements of the 6th West Lothian Scout Group ("the Group") for the year ended 31st March 2020 which are set out on pages 3 to 5.

Respective responsibilities of Trustees and Examiner

GSL Report April 2019 to March 2020

There are currently 15 Beaver Scouts, 21 Cub Scouts and 13 Scouts in the group and the sections are run by 7 leaders, 3 section assistants and 2 young leaders. 2 of our leaders hold 2 roles within the group.

Over the past year the leaders have provided a varied programme enabling our members to earn numerous badges while learning a range of new skills. A total of 338 badges have been awarded of which 10 were Chief Scout's Awards. Our leaders use an online system called OSM which makes record keeping and contacting parents much easier. Parents can also access their child's records to see their progress.

Activities undertaken over the past year included regular weekend camps for scouts, cubs and scouts taking part in the Wee Sleep Out to raise funds for the homeless and members from all sections took part in the Hike to the Moon to raise funds for Children in Need. A huge thank you to all those who participated in these fundraising efforts.

In March we had to suspend face to face scouting due to the coronavirus and had to look at other ways of delivering scouting to our members. Our leaders emailed work home to the children then introduced Zoom meetings, while still emailing work to those who did not attend the online meetings. Other scout groups shared information and ideas online which was really helpful. However Zoom meetings aren't for everyone but those who did take part seemed to enjoy them. But all our leaders much prefer face to face scouting.

BEAVER SECTION REPORT - FOR AGM 2020

There are currently 15 beavers in the section, 1 girl and 14 boys. One beaver recently moved up to cubs but due to the current situation we couldn't have a swim up for her.

Since the last AGM we have had a busy year with the beavers earning:

- 24 Challenge badges including the Adventure, Outdoors, Skills, Teamwork, Personal and World Challenge.
- 108 Activity badges including Cook, Explore, Global Issues, Health and Fitness, Hobbies, Experiment, Photographer, Collector, Cyclist, Builder and Digital Citizen
- 9 Membership badges
- 11 Joining In badges
- 4 Chief Scout's Bronze Awards.

Quite an achievement for them. There is also a new badge, the Peer Leadership badge for each lodge leader and 4 Beaver of the Month woggles are presented to the beavers who have good attendance, work hard, show good behaviour and help others.

In April 2019 some of our group members attended the St George's Day Annual Church Parade in Linlithgow. Beavers worked on badges for the rest of the session. In May 2019, Ian decided to become an Assistant Beaver Leader in addition to his role as Assistant Scout Leader. He clearly enjoys working with the beavers and teaching them real scouting skills.

After the summer break, the beavers earned their Digital Citizen and Photographer badge. In October we held a Halloween party and decorated the hall with spiders, skeletons and pumpkins. There were a few scary sights that night.

In November, Ian demonstrated how to make pancakes from scratch. Each beaver helped make their own, carefully observing the safety guidelines explained by Ian.

As part of his training for this role, he then had to plan and run the colony meeting which the beavers really enjoyed. Late November it was time to start making the Advent calendars, then Christmas cards and gifts which the beavers always enjoy.

Being a beaver isn't all hard work as they enjoyed the group outing to the pantomime at the King's Theatre in Edinburgh on 6th December. They had a great time, as did the leaders.

The winter session finished with a joint Christmas party with the cubs.

In January we started the Experiment badge and the Cook badge and the beavers enjoyed these, especially the Experiment badge which involved Polishing Pennies and Making a Vacuum. The Cook badge covers cleanliness and safety in the kitchen and making meals. Photos were proudly produced of homemade pizzas and other culinary delights.

Our Shrove Tuesday meeting had to include pancakes which went down well. In early March we started the Communicator and Team Skills badges. Then the Beavers enjoyed making and testing their Fire Extinguishers which took place outside as it was slightly messy but fun.

Then we had to stop face to face scouting which we all miss but we have adapted and will keep sending work home for the beavers to do for as long as necessary.

Another busy year has passed and all of these activities couldn't take place without the help of my two assistant beaver leaders, section assistant and two young leaders, when they are able to attend.
